Rothbury Hospital, Northumbria

The future of Rothbury Hospital is being debated following Northumberland County Council's referral to the Secretary of State regarding the process used by the local NHS which resulted in beds being closed. The Independent Reconfiguration Panel (IRP) concluded that there were flaws in the engagement and consultation processes and that further action locally is required. The Council has been asked by the Secretary of State for Health, Matt Hancock, to have further local discussions and report back by the end of January. Community campaigners have developed a vision for the hospital and are encouraging local people to support the reinstatement of the beds, and expansion of services in the hospital.

Wellington Community Hospital inpatient beds remain closed

Wellington Community Hospital will be closed to inpatients for longer than planned as it cannot currently "safely re-open". Inpatient beds were due to be occupied again later this month. This week's decision by Somerset Partnership NHS Foundation Trust for the facility to remain mothballed follows a review of nursing staffing levels across all community hospitals. A spokesman said: "Recent changes in staffing which mean that the inpatient ward at [Wellington](#) Community Hospital cannot safely reopen as planned." [Read more](#)

"I have expressed the view that, alongside the proposed reconfiguration of services in Shropshire, it is essential that some planned care is delivered locally in our local community hospitals in Llanidloes, Newtown, Welshpool and Machynlleth, to prevent the need to travel out of county to see a consultant. Moving forward, I will continue to campaign for NHS services to be delivered as close as possible to home and I have previously called on the Welsh Government to allocate additional funding to Powys Teaching Health Board for minor injury units and develop a Community Hospital Development Fund to encourage the innovative use of community hospitals across rural Wales. This would making community hospitals more sustainable and ensure that any additional economic, social

Birthing services at Okehampton Hospital suspended for THREE MORE MONTHS ahead of review

Birthing services at Okehampton Community Hospital are to remain suspended for a further three months — meaning the service has remained shuttered for more than 18 months. The Royal Devon and Exeter NHS Foundation Trust and Northern, Eastern and Western Devon Clinical Commissioning Group (NEW Devon CCG) have confirmed to the Times that the suspension of deliveries and overnight stays, due to unsafe staffing levels, is to continue until at least April, when the service will be reviewed.

Fears raised over future of Ripon Community Hospital

Health campaigners have raised fears about the future of community hospitals in North Yorkshire, including Ripon's. At a North Yorkshire scrutiny of health committee meeting, former chairman John Blackie said Ripon Community Hospital, among others, has a 'question mark' over its future, despite being a much-valued facility. Mr Blackie said: "Community hospitals are hugely valued and are seen as essential facilities by those the NHS is here to serve. They are under threat." Campaigners said they believe severe budgetary pressures facing the NHS in the county could lead to the closure or further downgrading of hospitals, including those at Whitby, Ripon, Richmond and Malton. Government announces £8m to change health services in Hinckley

But there are fears for the future of the Mount Road Hospital. A combined day case surgery and endoscopy unit will be created at Hinckley Community Hospital with day-case beds, which will provide an increased range of day case procedures and cancer screening services for local patients. The out-of-hours primary care service from Hinckley and Bosworth Community Hospital into

the new developed Urgent Care Hub in Hinckley Health Centre providing out-of-hours care for patients. “The investment means we can upgrade and improve facilities to ensure we can provide the highest standards of care quite rightly expected by people.”

Dene Barton and Chard Community Hospitals will remain closed until at least March 2019

BREXIT, the loss of bursaries and the lack of a university in Somerset have all been blamed for two community hospitals remaining closed. Ethna Bashford, the trust’s director of patient care, said Brexit had impacted on recruitment, with a number of European nurses returning overseas. The Somerset Partnership NHS Foundation Trust, which runs the county’s community hospitals, has confirmed [Wellington](#) community hospital’s inpatient ward will reopen in the new year. But the “fragile” staffing levels mean the inpatient wards at Chard and Dene Barton will not re-open until March 2019 at the earliest. [Read more](#)

Staffing crisis leads to further weekend closures at “vital” hospital unit

A recurring recruitment crisis has forced a “vital” Perthshire hospital unit to cancel all weekend openings for the rest of the year. NHS Tayside has confirmed restricted hours will stay in place at the minor injuries unit at Pitlochry Community Hospital throughout December. Hours were slashed at the hospital unit earlier this summer as a result of problems recruiting staff. SNP councillor Mike Williamson said the recruitment crisis was part of a wider issue. He said: “We need to look at the reasons we are struggling to bring new people into this area. Ongoing concerns about Brexit and Pitlochry High School, as well as a drop in EU migration, don’t help.” [Read more](#)

Rehabilitation unit will treat patients at home as well as at hospital under new plans

Patients with neurological or brain injury rehabilitation needs will receive specialist support in their own home and in hospital under new plans agreed this month. Nottinghamshire Healthcare NHS Foundation Trust will lead the operation, which will include a new community outreach service as well as inpatient beds on the Chatsworth Ward at [Mansfield](#) Community Hospital. In August 2017, the Trust said it was considering stopping the "unsustainable" service and closing the hospital's 16-bed Chatsworth ward. A DECISION to refurbish and reopen Castleberg Hospital in Giggleswick has been welcomed by Skipton MP Julian Smith. A meeting of the governing body of the Airedale, Wharfedale and Craven Clinical Commissioning Group (CCG) in Settle voted unanimously to keep the ten bed hospital open. The decision was taken to continue to provide inpatient care in the community and repair and restore Castleberg Hospital but in a redesigned way that will be determined with the involvement of the local community. Anne-Marie Trevelyan MP asked the PM in Prime Ministers Question time: *"Does the Prime Minister agree that the NHS should be investing in community hospitals?"*

Theresa May responded that she agreed that *"Community hospitals are a vital part of the range of services we want to see in our NHS"*. The MP said: *"The 12 in-bed provision at Rothbury Community Hospital in my constituency was removed without adequate consultation back in September 2016. The Save Rothbury Hospital campaign and I have worked closely together to get transparency on that decision and return the in-bed provision for our vast and sparsely populated Coquet valley."*

The matter has been referred to the Independent Reconfiguration Panel by Secretary of State for Health, Jeremy Hunt.

Campaign highlights importance of getting hospital patients out of bed earlier

Holsworthy Community Beds to Reopen

Beds at the town's hospital were temporarily closed back in March 2017, with Northern Devon Healthcare NHS Trust (NDHT) citing 'significant' safety concerns. However, healthcare commissioner Northern, Eastern and Western Devon Clinical Commissioning Group (NEW Devon CCG) has now written to the NDHT to formally request a programme to reopen beds. In a statement, the CCG said it was 'no longer able to support' the closure. [Read more](#)

Community Hospital Beds could reopen in June

Inpatient wards at Somerset's community hospitals could begin re-opening as early as June, provided that more nurses can be recruited. The Somerset Partnership NHS Foundation Trust operates 13 community hospitals across Somerset, providing more than 200 inpatient beds. Chard and Shepton Mallet's hospitals saw their in-patient wards temporarily closed in October, along with one of the two wards at Dene Barton hospital in Cotford St Luke near [Taunton](#). Now the trust has stated that it is "optimistic" that one of the sites could reopen soon as it strives to recruit more nurses from outside the European Union. Andy Heron, the trust's deputy chief executive and chief operating officer said: "We very, very much value our community hospitals. They will be part of the landscape going forward." [Read more](#)

Ceremony to officially open £417,000 Unit at hospital

The inpatient unit at Clevedon's North Somerset Community Hospital has been officially reopened after a £417,000 revamp. The building, made up of the Elton Rehabilitation Unit and Lister Ambulatory Unit, had been closed for almost two years. The number of beds has been reduced from 17 to 11, comprising three ambulatory care beds and eight rehabilitation beds. [Read more](#)

Close “lavish offices” instead of Thirsk hospital, says Peer

A MEMBER of the House of Lords says the NHS should have closed some of its “lavish offices” instead of Thirsk's Lambert Hospital, as she calls on the head of NHS England to overrule the decision. The Lambert Memorial Hospital closed in 2015, when South Tees NHS Hospital Trust announced the 14-bed facility would be temporarily shut with immediate effect, saying it was unable to find enough qualified nursing staff to operate the hospital safely. In an unprecedented move, councillors from Sowerby Parish Council, Thirsk Town Council, Hambleton District Council and North Yorkshire County Council formed the Lambert Hospital Action Group. The group, led by Hambleton council, wanted to purchase the building and use it as a health and community facility. [Read more](#)

Sarah Dugan, chief executive at Worcestershire Health and Care NHS Trust said “The hospital is valued by the trust and the local community and while there may be changes to the types of services

"Congratulations to a voluntary group in East Suffolk, who have bought back their local cottage hospital in Southwold to be used as a community hub, including space for start up businesses, a crèche, a community farm-to-fork café, a new, improved home for the local public library and some affordable housing. They have formed a Community Benefit Society called SouthGen, and are working in partnership with local organisations concerned with the needs of a largely elderly population.

Communities across England will be looking with interest, to learn from Southgen, which is the first to create a new community resource at their old hospital. The CHA knows of other communities who have taken the first step in registering their redundant hospital as a Community Asset, and are exploring ways of retaining their hospital sites to continue their role in contributing to community wellbeing.

Assurances sought ahead of community hospital bed closures

A Cumbrian peer is calling for reassurances about the future of the three county community hospitals set to lose their beds. Lord Roger Liddle, who represents Wigton on Cumbria County Council, has written to health boss Stephen Eames asking for a guarantee in writing on funding, services and staffing. NHS bosses agreed last year to remove beds from Wigton, Maryport and Alston hospitals, instead caring for more people at home, following the controversial Success Regime consultation. They have since been working with each community to draw up a vision showing how care will be provided and hospital buildings used in other ways, such as extended clinics.

Campaigners are demanding the NHS drops plans to close two community hospitals and replace them with a new single £11 million facility after local people rejected the idea. More than 3,000 people filled in a survey distributed across the Forest of Dean during a 12 week consultation into the plans put forward by health chiefs. Currently there are 47 beds between Lydney and the Dilke hospitals, while the minimum number of beds the new hospital would have is 24. Many others question the location of a new hospital, expressing fears that it would be difficult to reach using public transport in a rural areas, and the facilities that would be offered. Future of Rothbury Ward goes to the Secretary of State

Northumberland County Council's health and wellbeing overview and scrutiny committee has voted to refer the proposed closure of Rothbury ward. Last month the joint executive board of the Northumberland Clinical Commissioning Group (CCG) voted unanimously in favour of permanently closing the inpatient ward and shaping the existing services around a Health and Wellbeing Centre at the hospital. The closure is on hold and the final decision rests with the Health Secretary Jeremy Hunt. Katie Scott, from the Save Rothbury Community Hospital campaign group said at the meeting "Surely at all stages the scrutiny committee should have been consulted? It

seems to us that you have been ignored," she said. "I believe today is the first opportunity in over 14 months for the committee to fully examine the proposal to take away our beds."

Shaftesbury hospital beds saved in Dorset health service shake-up

Campaigners are jubilant after winning the battle to save beds at Shaftesbury hospital as part of a Dorset-wide review of health services.

The governing body of Dorset Clinical Commissioning Group voted to maintain a community hub with beds at the town's Westminster Memorial Hospital as part of a raft of proposals that will shape the future of health care provision in the county. But the hub is set to move from the hospital site as the CCG proposal also agreed it should stay until a new model for services is established. The Friends of Braintree Hospital says public must have say on proposed Braintree Community Hospital Ward changes

PROPOSED changes at Braintree Community Hospital should not take place before the public have had their say, a community group has said. The Friends of Braintree Community Hospital has promised to hold the Mid Essex Clinical Commissioning Group (CCG) to account over the plans, the nature of which are currently not clear. MP Layla Moran to bring community hospital cut concerns to health minister

THE FUTURE of Abingdon Community Hospital will be discussed at a meeting between Oxford West and Abingdon MP Layla Moran and Health Minister Steven Brine.

Ms Moran will be asking for a guarantee from the Government that patients will not face bed cuts or a reduction in services at the hospital as part of Oxfordshire Clinical Commissioning Group's controversial 'transformation plans'. A legal challenge to the changes was last week granted a full hearing. Ms Moran has already raised concerns about possible cuts to beds and services at the Abingdon hospital in the House of Commons and described the Marcham Road facility as a '*treasured asset*'.

Potters Bar hospital fears as figures show five services cut in a year

Potters Bar Community Hospital is facing an uncertain future after it emerged that five of its services have been cut in just over a year – with more potentially at risk. Since August 2016, Royal Free has stopped its Potters Bar-based ENT (ear, nose and throat) services, dermatology, general surgery and orthopaedics. Urology was also scrapped in June 2015. Potters Bar’s MP Oliver Dowden said: “Like many constituents I was concerned to learn about these changes to services at Potters Bar Community Hospital. “I have been in direct contact with the Royal Free to share these concerns and will soon be meeting personally with their chief executive, Sir David Sloman. “It is my understanding that the future of the hospital is fully secure, but I am seeking an urgent clarification from them and the local NHS clinical commissioning group, Herts Valley, about the reasons behind these decisions and the hospital.” [Read more](#)

Patients are being 'abandoned' despite plans to review minor injury unit closures

Withernsea Community Hospital in-patient unit was shut as a temporary measure last month. A month after its "temporary" closure Withernsea Community Hospital shows no sign of reopening to patients. Health Secretary Jeremy Hunt has called for a review of controversial plans to permanently close the hospital's minor injury unit and another in Hornsea, but neither City Healthcare Partnership nor East Riding Clinical Commissioning Group (CCG) have said when the hospital may reopen. Beverley and Holderness MP Graham Stuart has said while he welcomes the review, it does not "allay concerns" for Withernsea Community Hospital's immediate future.

Two hospitals set to close to make way for new £11million facility

Katie Norton, chief executive of Gloucestershire Care Services which runs the county's community hospitals, said she is "excited" by the opportunity to develop new facilities in the area. We hope these new facilities will enable us to provide a wider range of services. Sometimes we're not able to provide that consistency across the two sites. Currently there are 47 beds between Lydney and the Dilke hospitals, while the minimum number of beds the new hospital would have is 24. Bed occupancy at both hospitals is often at 95 per cent, but the NHS says only half of patients at both hospitals are from the Forest of Dean. Health bosses believe 24 beds would be a "robust number to support the locality." The new publicly-funded hospital could provide an endoscopy suite, but will not include a birthing unit or operating centre.
